Childcare Terms and Conditions 2026-27



- Learners acknowledge that they must not commence use of any childcare provider until their bursary application has been fully completed, and all required supporting evidence has been submitted and approved.
- Learners understand that if they withdraw from, or leave, their course, it is their responsibility to notify both us and the childcare provider with appropriate notice in line with provider requirements.
- We will continue to support childcare costs only during the agreed notice period, in accordance with the individual nursery or childcare provider's terms and conditions.
- Childcare payments are made either monthly or termly in arrears directly to the childcare provider, subject to verified attendance records. Attendance is monitored regularly, and funding may be reduced or stopped where attendance falls below 90% without valid reason or prior notification.
- Butterflies Nursery: The Bursary may be able to cover 100% of your childcare fees, subject to a completed and approved application.
- Private childcare: The Bursary will contribute 80% of the private childcare costs. The remaining 20% must be paid directly by you to your childcare provider, and we kindly ask that this contribution is made promptly when requested by the childcare provider.
